What an incredible year this was for FPS! We are so lucky to be able to count on thousands of joy givers that give generously of their time and treasure to ensure FPS families can take a break from cancer.

Our office received 876 program inquiries - resulting in 254 families served (this includes families nominated in the prior year but traveled in the 18-19 year). A sharpened focus on serving the emotional needs of our patients, caregivers, and children beyond the respite resulted in an emphasis on offering our Ancillary Support. Our staff and volunteers connected with patients and caregivers 13,222 times to provide resources, emotional support, guidance and time together to celebrate the goodness of life!

Behind these numbers are faces - faces of patients, caregivers and children - who have received devastating news. We were able to transform their outlook because of a respite experience YOU provided. YOU help them laugh. YOU help them remember. YOU help them create moments in time. Your own face is forever etched in the smile on their face.

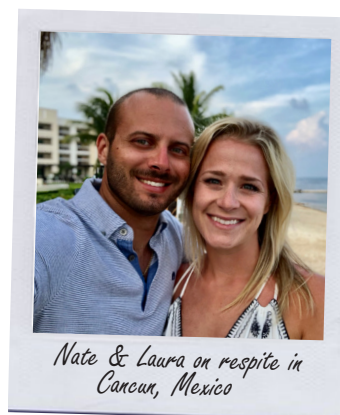

OUR NOMINATORS

Oncology Professionals that nominate their patients to take a respite experience are the backbone of our mission. We have received at least one nomination from 700 oncology professionals since our inception. FPS is the only nonprofit in the country that exclusively provides respite experiences to adult cancer patients with all cancer types.

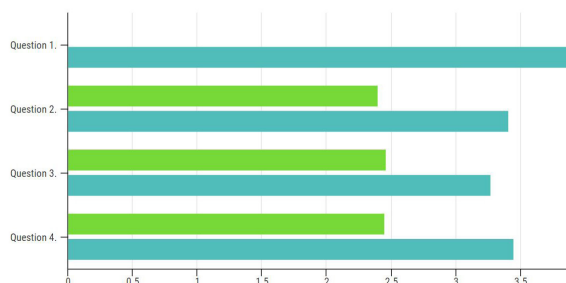

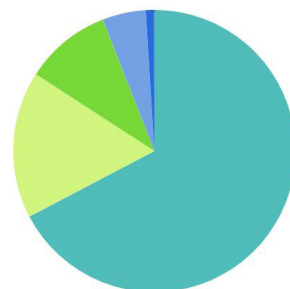

AS FEATURED IN THE SEA ISLE NEWS

For a few precious hours Tammy Grosso was able to temporarily forget about all of the consultations with her oncologists, her chemotherapy treatments and the cancer that threatens her life.

She spent the day on the beach in Sea Isle City with her 17-year-old son, Christian, and 13-year-old daughter, Amanda, while enjoying a getaway from the emotional and physical toll of cancer.

“I want to spend as much time as I can with my kids,” said Grosso, a single mother who also has a 15-year-old son named Micah.

Grosso and her children were part of a group of nearly 40 people who came to Sea Isle for a relaxing outing organized by a nonprofit organization called For Pete’s Sake Cancer Respite Foundation.

COMMUNITY RESPITE PILOT

STRANGERS BECOME 'EXTENDED FAMILY' THROUGH RESPITE

For Pete's Sake Cancer Respite Foundation completed five community respites as part of our pilot to study the effectiveness of multiple families traveling concurrently. Our community respites took place at Woodloch Resorts, Spruce Lake, and Camp Wavus. We discovered an incredible amount of positive feedback about the impact of community and shared experience in improving outlooks on living with cancer. We look forward to continuing our community respite expansion!



A PROFOUND SENSE OF COMMUNITY

Recipients of community respites feel a heightened sense of connection with the other travelers, thus creating a beautiful organic relationship that continues to evolve long after the respite. They report that the time spent on community respites helps in coping with their current situation knowing that they have these newfound relationships they can depend on.

MEMORIES THAT LAST A LIFETIME

Community respites provide ample opportunities for families to engage in activities together to reconnect and rejuvenate their relationship! Children have the ability to socialize within a safe haven that promotes communication and friendship amongst other families. Many travelers remain friends and in frequent contact due to these newfound relationships.

AN IMPROVED OUTLOOK

Patients and caregivers from our community respites report experiencing improved communication, less concern about future treatment and feel more refreshed following their community respite experience. The time spent within these respites are transformative and have lasting impacts that combat the psychosocial effects caused by a cancer diagnosis.

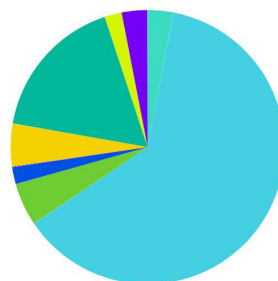
WE PRIDE OURSELVES IN BEING EXCELLENT STEWARDS OF OUR DONORS' DOLLARS

NET ASSETS OVERVIEW

WE WANT TO ENSURE FPS IS AN ONGOING SOURCE OF RESPITE FOR CANCER PATIENTS!

To ensure our future sustainability, FPS started an endowment and actively manages its reserves. These items reflect on the fiscal health of the organization by providing continuous income and also mitigation during economic downturns. The Board, relying on the expertise of the Finance and Audit Committees, ensures that targets related to the endowment and reserves are maintained. Also, since FPS is the owner of two unencumbered Florida homes, management of assets is important to maintain the value of the organization's real property assets. The chart below reflects the Net Assets at the fiscal year end on June 30, 2019.

NET ASSETS WITHOUT DONOR RESTRICTIONS

You will notice that FPS had a substantial increase in its net assets without donor restrictions. This happened because the organization received its two largest individual donations in its history this past year and thus, the Board created a Board designated endowment with a significant proportion of these funds. By definition, net assets are available for use in general operations and not subject to donor restrictions yet can be limited by Board designation.

NET ASSETS WITH DONOR RESTRICTIONS

Some assets are subject to donor-imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both.

During fiscal year 2014, FPS received a donation in the form of an irrevocable Charitable Remainder Unitrust. In each taxable year of the trust and during the life of the donor the trustees will pay to the donor an amount equal to 5% of the net fair value of the assets of the trust. Upon the death of the donor, the trustees will distribute to FPS 40% of the then principal and income of the trust. As of June 30, 2019, and 2018, the fair value of FPS's portion of its beneficial interest in the charitable remainder trust was \$231,419 and \$244,249, respectively, recorded as an asset on the Organization's statement of financial position. During the life of the donor, earnings on the trust assets will be recorded at the beginning of each year as a change in the beneficial interest in a charitable remainder trust on the statement of activities with a corresponding change in the asset.

STRATEGIC PLANNING

This fiscal year, the FPS team began development of its 2030 Strategic Plan. The plan's vision is based on the premise that FPS will be the foremost organization in improving the ability of cancer patients and families to cope with cancer through life changing respite experiences.
